Membership Work Commitment:

- Every CHDA member must fulfill their volunteer commitments for the membership year – regardless of the age or level of the dancer.
- There are only 2 shift requirements for each member this year. For information on volunteer positions contact CHDA at fling@chda.ab.ca.
- Work assignments will be done just prior to each competition.
- You must provide 2 cheques for \$50.00 each to secure your CHDA volunteer commitment. These cheques should be dated **June 1, 2011**. If you don't show up when scheduled, your cheque will be cashed AND you will still be required to fulfill the work time.

Fees:

- We are required by Alberta Highland Dancing Association (AHDA) to collect \$15.00 per dancer in lieu of fundraising activities. You may combine both membership fees and AHDA fees on one cheque. Membership work commitment cheques are separate.
- All cheques should be made payable to the **Calgary Highland Dancing Association**.

Mailing Dates:

Registration opens August 23, 2010, and must be post-marked no later than **September 30, 2010**.

Please note any registrations submitted AFTER September 30, 2010 may take 4 weeks to process, and membership information may not be received by you prior to the November, 2010 CHDA competition.

The CHDA Annual General Meeting will be September 13, 2010. You are invited to come and meet the executive who will be on hand to answer questions about CHDA, its mission, function and procedures.
